## On the Covid-19 crisis with an eye to the future

Dear friends,

Here we are again after another long and exhausting period of restrictions, followed by a period of fewer restrictions, which partially reduced the early uncertainties about our future and strengthened our hope of a return to normal life.

We feared for our loved ones' safety and our own but the desire to avoid the contagion has always supported us. We have often been overwhelmed by discouragement for what has been happening since many, too many did not make it and many others suffered and still suffer from the consequences.

Our best wishes for a quick recovery to all those who have been affected by Covid 19.

We are saddened by the fact that, despite all our efforts, the risk of contracting the virus is still strong. It could happen through our fault, but also because of the irresponsible behaviour of others.

Nobody has the right to put others in danger.

But let's focus on our Association. Due to Covid, we were unable to carry out any activities. So, it was decided to consider the annual fee (Euro 20.00) valid for 2021. This means that those who have already paid the fee do not have to renew it for next year, those who have not yet paid it are asked to do it as soon as possible

Our premises are now open once a week but we are always available. We look for volunteers to help us to keep them open when things revert to normal.

The uncertainty about the future does not yet allow us to organize the traditional appointments but there will be a General Meeting as soon as possible. We cannot decide on the date because it is still premature: the infection is on the rise and a difficult autumn is expected.

We have been informed that San Giorgio Awards Ceremony will not be held this year. We have decided to hand out the scholarships at the first post lockdown event.

In the meantime, lessons at school have begun. Not everything went well. The pandemic has highlighted all the flaws in our school system .

For the centenary of ITN "San Giorgio", we will do our part, as we have always done since the first day of our foundation.

In 2021 our glorious "*Nautico San Giorgio*" will be 100 years old and in 2022 our Association will be 35 years old.

It may seem strange that an Association like ours, made up of "elderly people" may be lively and sprightly and look forward, look to the future.

In 2021 we will celebrate our beloved Nautico in the best possible way.

By the way, if you have any ideas on how to organise the event, please let us know. We must be ready and well prepared.

Let's sum up our history.

**4** In 1816, thanks to Admiral Giorgio des Geneys, the "Scuola Nautica Statale" of the Merchant Navy was established in Genoa. The *ordinanza* of March 9, 1816, chap. VII, paragraph 77, reads as follows:

"A Scuola Nautica will be set up in each of our cities of Genoa, Nice and Cagliari".

The *Gazzetta di Genova* of 7 August, 1816 writes: "H.M., on 31 July, 1816, appointed *Cav. Antonio Davico* from *Finale* to the position of 1st teacher of Mathematics and Maritime Subjects in Genoa for the Merchant Navy. Yesterday he swore allegiance in the hands General *Conte des Geneys*, Head of the Admiralty.

At that time the *Scuola Nautica Statale* was located in premises belonging to the Navy near the port. Lessons were also held in the Admiralty Building. *Palazzo dell'Ammiragliato* 

- **From 1853 to 1865 the School premises were in** *Vico San Matteo*, in *Palazzo Pagano Doria*, then *De Amicis* (the last building, on the right going down towards *Campetto*, next to *Palazzo Imperiale*)
- **4** From 1866 to 1920 the premises of *Nautico* were in Largo della Zecca. Immediately after the unification of Italy, the king decreed that all *capoluoghi* should have a Technical School.

Genoa rented *Palazzo Rostan Reggio*, formerly belonging to *Bartolomeo Lomellini* in Largo della Zecca, a prestigious building in an elegant area not far from the historic centre. The School , which later took the name of ''*Vittorio Emanuele II*'', had four sections

- 1. Commerce and Accounting
- 2. Physics and Mathematics
- 3. \*Agriculture
- 4. Maritime studies divided into five sections: Capitani di Lungo Corso, Capitani di Gran Cabotaggio, Macchinisti in Prima, Macchinisti in Seconda, Costruttori Navali

(We thank Prof. Armando Fossati, Headmaster Emeritus of Vittorio Emanuele II, for helping us in our research, allowing us to consult all sorts of documents.)

- In 1921, Nautico became autonomous, taking the name of "Istituto Tecnico Nautico Statale - San Giorgio" di Genoa" and moved (apparently only temporarily) to Piazza Palermo.
- In 2007, Nautico moved to Calata Darsena and was named "Istituto Tecnico dei Trasporti e della Logistica – Nautico San Giorgio"

In the next "Carretta" we will focus on Piazza Palermo and on the 35 years of our Association.

Seafood recipe by J.R.: Tuna 'alla scapece'



It is a classic recipe from southern Italy , tasty and easy to prepare.

Ingredients (for 4/5 people)

- 6/7 hectograms of tuna (better from the belly)
- garlic : two cloves
- 1 kg of sliced onions
- a glass of white vinegar
- olive oil as required

## **Preparation**

- Cut the tuna into 2 cm slices and then into 3-4 pieces each.
- Fry them in boiling oil with two cloves of garlic until they are browned.
- Drain and set aside.
- In the same pan, fry about 1 kg of sliced onions
- When they are browned, turn off the heat and pour half a glass of white vinegar. Let it rest under a lid.
- Put the tuna in a baking dish and cover it with the fried onion and the remaining oil.
- If necessary, sprinkle with oil. The more you let it rest, the tastier it becomes,
